SUPPLEMENTAL BOND ORDINANCE DATED SEPTEMBER 2, 2020.

AN ORDINANCE SUPPLEMENTING A BOND ORDINANCE DATED AND DULY ADOPTED ON SEPTEMBER 4, 2019 OF SAID CITY.

WHEREAS, on September 4, 2019, the Common Council of the City of Lockport, Niagara County, New York (the "City") duly adopted a bond ordinance to finance the cost of effluent disinfection upgrade project at the Wastewater Treatment Plant, including original furnishings, equipment, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, in and for said City (the "Project"), a specific object or purpose, at a maximum estimated cost of \$3,125,000, with \$3,125,000 bonds authorized to be issued therefor (the "Bond Ordinance"); and

WHEREAS, on May 15, 2019 the Common Council had adopted a resolution determining said capital project to be an Unlisted Action and thereby superseding a 2017 resolution of the Common Council determining said project to be a Type II Action; and

WHEREAS, the bond ordinance duly adopted on September 4, 2019 inadvertently referred to the earlier SEQRA determination; and

WHEREAS, it is desirable to supplement and amend the bond resolution accordingly, NOW, THEREFORE

BE IT RESOLVED by the affirmative vote of not less than two-thirds of the total voting strength of the Common Council of the City of Lockport, Niagara County, New York as follows:

The first Whereas clause of the Bond Ordinance dated and duly adopted on Section 1. September 4, 2019 is hereby amended to read as follows:

"WHEREAS, the capital project hereinafter described has been determined to be an Unlisted Action pursuant to the regulations of the NYS Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed, it has been determined will not result in any significant adverse environmental impact."

<u>Section 2.</u> The summary legal notice of estoppel attached hereto shall be published in the official newspaper of the City by the City Clerk.

<u>Section 3.</u> This ordinance shall take effect immediately.

Whereas, per Resolution 121918.5 Kandey Company, Inc. (Kandey) was awarded a contract for \$6,712,145.00 for the construction of the project, with two subsequently approved Change Orders increasing Kandey's contract to \$7,149,545.00; and

Whereas, construction of the project is complete and Kandey has submitted a request for Change Order No. 3 (Final), inclusive of paving the Water Treatment Plant parking lot and final adjustment of Contract Unit Items for a credit of \$315,988.90 resulting in a final Contract amount of \$6,833,556.10 as reviewed and recommend by the City's consulting engineer GHD on August 10, 2020, now, therefore, be it

Whereas, the City of Lockport (City), applied for and has received a Streetscape Green Infrastructure Enhancement Project Grant for the following streets: Pine St., South St. and Washburn St. (EFC Project No. C9-6659-17-00) via the New York Consolidated Funding Application (CFA) to the Green Innovation Grant Program (GIGP); and

Whereas, the City was has received an Executed Agreement from the New York State Environmental Facilities Corporation (NYSEFC) for \$1,500,000 of the project cost including Professional Engineering Services; and

Whereas, Nussbaumer & Clarke, Inc. (Nussbaumer), prepared the Project Feasibility Study which was approved by NYSEFC and the New York State Department of Environmental Conservation (NYSDEC) in May 2020, said firm is on the City's pre-qualified list of engineering service providers, and said firm submitted a proposal dated August 27, 2020 in accordance with the City's agreement with EFC for a fee not-to-exceed \$288,079; now, therefore, be it

Resolved, that the Mayor is authorized to execute an Agreement with Nussbaumer & Clarke, Inc., 80 Main St. Unit A, Lockport NY 14094 for a fee not-to-exceed \$288,079 per their proposal dated August 27, 2020, contingent upon review and approval by NYSEFC.

WHEREAS, Ruhlmann Farm Acres LLC, and the Applicant/Sponsor, OYA Ruhlmann A LLC, applied for site plan and special use permit approval, for a proposed solar energy system operation of a 5 MWAC/7.5 MWDC solar project on its property located at 251 Summit Street, Lockport, that will occupy approximately 32.81 aces of the 43 acres total area of the parcel; and

WHEREAS, Ruhlmann Farm Acres LLC, and the Applicant/Sponsor, OYA Ruhlmann B LLC, applied for site plan and special use permit approval, for a proposed solar energy system operation of a 2.125 MW/2.964 MWDC solar project on its property located at 219 Summit Street, Lockport, that will occupy approximately 13.46 acres of the 16.46 acres total area of the parcel; and

WHEREAS, the City has classified this project as Type 1 action, and is coordinating the review of same pursuant to the State Environmental Quality Review Act; and

WHEREAS, pursuant to 6 NYCRR Part 617, pertaining to Article 8 of the Environmental Conservation Law (State Environmental Quality Review), the City Council would like to establish itself as Lead Agency for said projects, and therefore mailed a request to act as Lead Agency to the appropriate and involved agencies along with copies of the special use permit application and site plan; and

WHEREAS, no appropriate or involved agency responded within the requisite 30 days to said request; and

NOW, THEREFORE, BE IT RESOLVED, that that the City of Lockport hereby declares itself as Lead Agency for the OYA Ruhlmann A LLC and OYA Ruhlmann B LLC solar projects located at 219 and 251 Summit Street, Lockport, New York 14094.
