Whereas, COVID-19 has had significant impact on the financial security of the City of Lockport since early FY 2020;

Whereas, the City of Lockport's FY 2021 Appropriated Budget was developed in a particularly conservative nature, as typical revenue sources had uncertain futures;

Whereas, the City has now acquired unbudgeted revenue sources (State AIM funds) that have been received and recommended by the NYS Comptroller' Office to be accounted for in the 2021 fiscal year;

Whereas, the administration has compiled a recommendation to the use of these funds in form of a FY 2021 Supplemental Budget #1, which proposes that said funds be appropriated for three distinct purposes - (1) a parks improvement program to revitalize the City's parkscapes, infrastructure, and equipment (with associated capital project to account for purchases), (2) to appropriate all revenues and expenditures found in the FY 2021 Mayor's Recommended Budget for the Playground and Recreation Centers, Marina, and Community Pool, and (3) to contribute funds to the negative budgeted line item for turnover and vacancy savings as per OSC recommendation;

Resolved, that the FY 2021 General Fund and Capital Budget be updated to reflect these changes described above with full line-item detail in the attached handout.

Whereas, the City wishes to allow for a waiver of said fee on an annual basis, after the initial fee is paid in year one, for the same application; now, therefore, be it

Resolved, that the City of Lockport Common Council hereby waives the annual fee of \$100 per applicant, for a revocable permit for using the City right-of-way, after the first year fee of \$100 is paid. If an applicant's permit request is the same annually, after the initial fee of \$100 is paid, said fee will be waived each year thereafter that the applicant applies for the waiver; and be it further

Resolved, applicants must still make the annual application for the waiver, but the fee will be waived. Said waiver of fee does not guarantee permission of a revocable permit on an annual basis; and be it further
