CRISIS SERVICES RESTRUCTURING DUE TO INCREASED DEMAND/BUDGET MODIFICATION NIAGARA COUNTY DEPARTMENT OF MENTAL HEALTH & SUBSTANCE ABUSE SVCS

WHEREAS, the Niagara County Department of Mental Health and Substance Abuse Services (NCDMH) is committed to providing exceptional treatment and integrated care services to Niagara County residents in need, and

WHEREAS, NCDMH provides a Crisis Services Call Center and Mobile Crisis Response (24/7/365) to address the needs of Niagara County citizens who are experiencing suicidal, mental health, substance use and other related emergencies, and

WHEREAS, calls to the Crisis Services Call Center for mental health and other related emergencies are steadily increasing, including a 30% increase in call volume in 2020 over 2019, and

WHEREAS, calls to Crisis Services in 2020 were 33% higher than the most recent 5 year average, and

WHEREAS, the need for on site, community-based intervention by the Mobile Crisis Team has also continued to rise steadily, including by 25% in 2020, and

WHEREAS, the numbers of individuals who are experiencing anxiety, depression, suicidal ideation, and substance use overdoses rose during the COVID-19 public health emergency and continue to rise despite the "reopening" of New York state, and

WHEREAS, public feedback given during Police Reform meetings and implemented plans have identified the need for Mental Health clinician support to Law Enforcement who are responding to individuals in crisis, and

WHEREAS, the Niagara County Sheriff's Department recently received approval to expand countywide the Mobile Zoom Telehealth Program, which allows deputies to access the Crisis Services Mobile Team via Ipad technology, and

WHEREAS, a Licensed Clinician position in the Crisis Services Program will provide direct support for these services, which is necessary to address the steady increase in Mobile Crisis calls, and

WHEREAS, upon evaluation of the increased demands and the needs of the Department, it was determined that a Licensed Clinician Position, working during high call volume hours, would allow for a higher level of service to the residents of Niagara County, and

WHEREAS, it has also been identified that expanding a current Part Time (0.8 FTE) Crisis Services Phone Aide position to a Full Time position will facilitate changes to work flow to allow Phone Aides to complete required documentation and shift reports in a timely fashion, and

WHEREAS, NCDMH is committed to and has demonstrated operating in a responsible fiscal manner, and

WHEREAS, the Licensed Clinician and Crisis Services Phone Aide positions are supported 100% through State Aid and generated revenue, and no additional current cost to the County, now, therefore, be it

RESOLVED, that one Licensed Clinician, Grade 11, Step 1, position number, MHD300100.XXXXX, salary range \$51,046.38 - \$59,669.82 be created within the Niagara County Department of Mental Health, and filled effective September 6, 2021, and be it further

RESOLVED, that one Part Time (0.8 FTE) Crisis Services Phone Aide, Grade 5, Step 2, position number MHD300100.13481, be abolished effective September 6, 2021, and be it further


